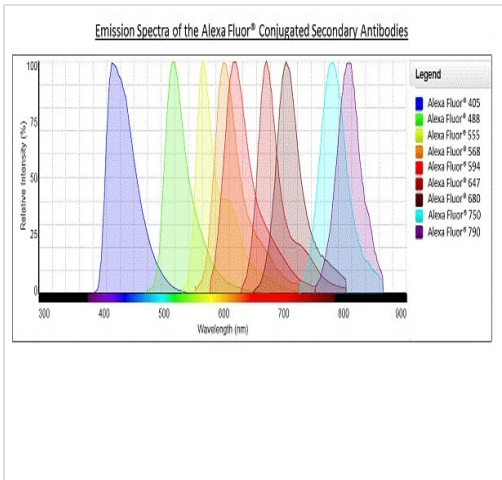

ICC/IF image of [ab6046](#) stained HeLa cells. The cells were 100% methanol fixed (5 min), permeabilized with 0.1% Triton X-100 for 5 minutes and then incubated in 1%BSA / 10% normal Donkey serum / 0.3M glycine in 0.1% PBS-Tween for 1h to block non-specific protein-protein interactions. The cells were then incubated with the antibody ([ab6046](#), 5µg/ml) overnight at +4°C. The secondary antibody (red) was ab181347 Alexa Fluor® 647 Donkey F(ab')<sub>2</sub> polyclonal Secondary Antibody to Rabbit IgG (H+L) used at 1µg/ml for 1h. DAPI was used to stain the cell nuclei (blue) at a concentration of 1.43µM.

The negative control (inset) is a secondary-only assay to demonstrate low non-specific binding of the secondary antibody.
