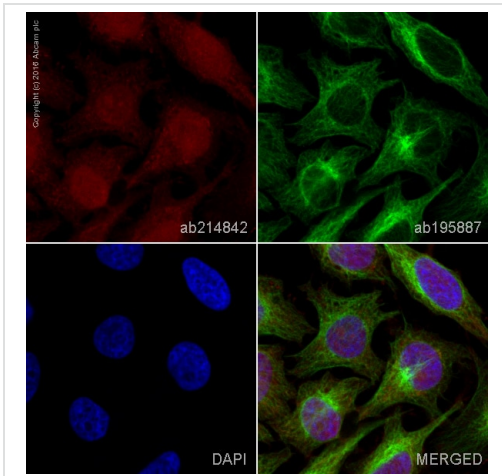

Immunocytochemistry/ Immunofluorescence - Alexa Fluor® 594 Anti-p38 beta/MAPK11 + p38 alpha/MAPK14 antibody [Y122] (ab214842)

ab214842 staining p38 in HeLa cells. The cells were fixed with 4% formaldehyde (10 min), permeabilized with 0.1% Triton X-100 for 5 minutes and then blocked with 1% BSA/10% normal goat serum/0.3M glycine in 0.1% PBS-Tween for 1h. The cells were then incubated overnight at +4°C with ab214842 at 1/100 dilution (**pseudocolored in red**) and **ab195887**, Mouse monoclonal to alpha Tubulin (Alexa Fluor® 488), at 1/250 dilution (shown in green). Nuclear DNA was labelled with DAPI (shown in blue).

Image was taken with a confocal microscope (Leica-Microsystems, TCS SP8).
